What You're Testing

The Movement Companion is a single app with **four intelligent tools** built for the humans doing movement work. Each companion has its own pre-loaded demo knowledge base and can also work with your own documents — kept completely separate.

1. **Financial Intelligence** — Makes budget planning accessible to everyone
2. **Knowledge Management** — Preserves organizing wisdom across staff changes
3. **Impact Storytelling** — Connects data with human stories powerfully
4. **Document Intelligence** — Analyzes any uploaded document with AI

Dual Knowledge Base (Data Sovereignty in Action)

The demo features a dual knowledge base system that demonstrates data sovereignty principles:

- **Demo Data mode** — Pre-loaded Community Justice Alliance documents. Always available, read-only. Chat bubbles show a "Demo Data" badge.
- **Your Data mode** — Upload your own documents, paste text, or describe your org. Session-only, processed in your browser. Chat bubbles show a "Your Data" badge. Cleared when you leave.

The two knowledge bases are completely isolated — switching modes means the companion only draws from that source, never mixing them.

Companion 1: Financial Intelligence

"Finally, budgets that make sense to program people"

What This Does

Translates between money language and mission language. Whether you're a community organizer wondering about program costs or a development director modeling funding scenarios, this companion speaks your language.

Key Capabilities

- "How did we double our Legal Aid capacity in 2023?"

Why This Matters

Every time someone leaves your organization, they take knowledge with them. The Community Justice Alliance experienced 40% turnover in 2022 — this companion helps ensure that hard-won lessons, key relationships, and effective strategies stay with your community.

Companion 3: Impact Storytelling

"Your data and stories, working together"

What This Does

Weaves together your numbers and narratives to show the full picture of your impact. Perfect for funders who need data, community members who connect with stories, and board members who want both.

Key Capabilities

- **Story + Data Integration:** Connect human experiences with measurable outcomes
- **Audience-Specific Reports:** Same impact, different framings for different people
- **Ripple Effect Analysis:** Show how individual changes create community transformation

Companion 4: Document Intelligence

"Upload anything. Get answers."

What This Does

A general-purpose document analysis tool. Upload any PDF, text file, or CSV and ask questions about it. This companion works exclusively with your uploaded content — not the demo data — demonstrating how the system can analyze any organizational document.

Try This Workflow

1. Click the upload button (paperclip icon) in the chat
2. Upload a document, paste text, or use the org context form
3. Ask questions about what you uploaded
4. Notice the "Your Data" badge on responses — confirming it's using only your content

All document processing happens in your browser. Nothing is stored on external servers. Your data is cleared when you end the session.

How to Evaluate What You See

What Makes a Good Response

- ✓ **Accuracy:** Information matches the source documents
- ✓ **Relevance:** Directly answers your question
- ✓ **Context:** Includes background that helps you understand
- ✓ **Accessibility:** Uses language appropriate to your role
- ✓ **Actionability:** Suggests next steps when helpful
- ✓ **Source Attribution:** Chat bubbles show "Demo Data" or "Your Data" badges

Red Flags to Watch For

- **Vague sourcing:** "Based on the data..." (instead of naming specific documents)
- **Inconsistent numbers:** Different totals for the same question
- **Made-up details:** Claims without clear source references
- **Math errors:** Calculations that don't add up when you check
- **Wrong mode:** Citing demo data when you're in Your Data mode, or vice versa

Quick Verification Tricks

1. **Ask for sources:** "What document did you get that from?"
2. **Test calculations:** "Show me how you calculated that"
3. **Check consistency:** Ask the same question different ways
4. **Cross-reference:** Ask related questions that should align

Troubleshooting
